- 3) To please Agricultural Consumption on the basis of Commission Own Norms of 1318 Hours/HP/Annum and the connected load should be pegged at 4.25 HP per consumer or To please confirm the Agricultural Consumption on the basis of the Agricultrual Consumption Committee Recommendations and IIT report as admitted by MSEDCL itself in its MYT Petition.
- 4) To please issue any other necessary /concerned/additional directions in the interest of justice as this Honourable Commission may think fit & proper.
