

NOTICE

Subject: Petition of Gigaplex Estate Private Limited for approval of PPA and adoption of tariff for procurement of 2 MW RTC Power and 1 MW Power from 08:00 to 23:00 hours for a period of six months from April 19, 2017 to September 30, 2017.

- **Case No. 48 of 2017**

Gigaplex Estate Private Limited (GEPL), has submitted a Petition under affidavit on 24.03.2017 under Section 63 & 86(1)(b) the Electricity Act, 2003 for approval of PPA and adoption of tariff for procurement of 2 MW RTC Power and 1 MW Power from 08:00 to 23:00 hours for a period of six months from April 19, 2017 to September 30, 2017.

The main prayers of the Petitioner are as under-

- i) *to adopt the tariff of Rs. 3.49/kWh for supply of 2 MW RTC Power and the tariff of Rs. 3.74/kWh for supply of 1 MW Power from 08:00 to 23:00 (on weekdays i.e. Monday to Friday) hours for a period of six months from April 19, 2017 to September 30, 2017, discovered through e-Bidding Process in accordance with the 'Guidelines for Short-term (i.e., for a period less than or equal to one year) Procurement of Power by Distribution Licensees Through Tariff Based Bidding Process' issued by Ministry of Power, Government of India, on March 30, 2016.*
- ii) *to approve the PPA signed between the Petitioner and M/s Global Energy Pvt. Ltd. under Section 86(1)(b) of the Electricity Act, 2003.*
- iii) *Condone any inadvertent omissions/errors/shortcomings and permit the Petitioner to add/change/modify/alter this filing and make further submissions as may be required at a further date.*
- iv) *Pass such Orders as the Hon'ble Commission may deem fit in the facts of the present case.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized Consumer Representatives on **Thursday, 13 April, 2017 at 11.30 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Commission has impleaded M/s Global Energy Pvt. Ltd. as party to the Petition.

4. The Petitioner is directed to serve a copy of its above Petition (both in soft and hard copy) to the authorized Institutional Consumer Representatives and M/s Global Energy Pvt. Ltd.

5. The authorized Institutional Consumer Representatives and M/s Global Energy Pvt. Ltd. are directed to submit the say in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and Global Energy Pvt. Ltd.,

6. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible, and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
