Nidar Utilities Panvel LLP ((NUP LLP) has submitted a Petition under affidavit on 24.03.2017 under Section 61 & 62 the Electricity Act, 2003 under the 2nd proviso to Regulation 5.1 of the MERC (Multi-Year Tariff) Regulations, 2015 for approval of a provisional tariff for the operation to be commenced in the SEZ area to be co-developed by Nidar Utilities Panvel LLP (NUP LLP/ Co-Developer) at Panvel, District Raigarh, Maharashtra.

The main prayers of the Petitioner are as under-

- a) Allow NUP LLP to charge consumers in the SEZ area as proposed in the petition, a uniform tariff of Rs.8.51 per kWh for each category of consumers except temporary consumer category till such time the ARR is filed by NUP LLP and Tariff is determined by this Hon'ble Commission.
- b) Allow NUP LLP to charge consumers taking temporary/construction supply in the SEZ area, an average billing tariff equivalent to Rs.13.48 per kWh, i.e. Temporary Tariff for HT Category relevant to FY 2017-18 as approved in 3rd November 2016 Tariff Order of MSEDCL.
- c) Allow the category of consumers such as Public lighting, Public water workds and Sewerage treatment plant to be included in the Public Services category for applicability of tariff.
- d) Allow NUP LLP to charge higher of the Fixed / Demand charges as per Paragraph 3.12 (as per MSEDCL Tariff order dated 3rd November 2016) or the Monthly bill on the basis of provisional tariff whichever is higher.
- *e)* Allow NUP LLP to charge consumers in its License Area the same Schedule of Charges that is applicable in the MSEDCL area of supply, as modified from time to time.
- *f)* To allow this Interim Arrangement till the finalization of the tariff.
- *g)* To pass any other order / relief as the Hon'ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice;

h) To condone any error/omission and to give opportunity to rectify the same;

i) To permit NUP LLP to make further submissions, additions and alterations to this Petition as may be necessary from time to time.
