Subject: Petition filed by Smt. Prabha Shankarrao Dhote in the matter of Order Passed by the Honorable District Magistrate, Wardha on 17th December 2016 in Case No 64 of 2016 and rejection of application for review.

- **Case No. 56 of 2017**

Smt. Prabha Shankarrao Dhote has submitted a Petition under affidavit on 11.04.2017 under Rule 3 of the MEW of Licensees Rules, 2012 and in the matter of Section 67, 68 and 164 of the EA, 2003, Part III of the Indian Telegraph Act, 1885, IS:5613 (Part 2/Sec 2)-1985 and Central Electricity Authority(Measures relating to safety and Electric Supply) Regulation 2010 the Order Passed by the Honorable District Magistrate, Wardha on 17th December 2016 in Case No 64 of 2016 and rejection of application for review.

The main prayers of the Petitioner are as under-

- i). *Quash and Set aside the order passed by the Honorable District Magistrate, Wardha on 17/12/2016.*
- ii). *Direct the Non-applicant no.2 and 3 to remove the Tower installed at plot no.80 and if not possible to pay full compensation for the area 450.51 square Meter of N.A. plot as per statutory provision along with interest on the quantum of fair compensation.*
- iii). *Direct the Non Applicant 1 to determine the compensation as per Sub Rule (2) of Rule 3 of Maharashtra Electricity Work of Licensees Rules, 2012.*
- iv). *Saddled the Cost to the Non Applicant no. 2 and 3 for defying the statutory provisions and for irreparable loss to the Applicant.*
- v). *Pass such other order, direction or relief this Honorable Commission deems fit and proper in the facts and circumstances of the case.*

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible, and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
