Subject: Petition of The Tata Power Company Limited seeking review of the existing Standby Arrangement provided by MSEDCL to the Mumbai Distribution area.

- **Case No. 53 of 2017**

The Tata Power Company Limited has submitted a Petition under affidavit on 10.04.2017 seeking review of the existing Standby Arrangement provided by MSEDCL to the Mumbai Distribution area.

The main prayers of the Petitioner are as under-

- a) *Admit the Petition;*
- b) *Review the existing Standby Arrangement in totality in light of the many changes that the electricity industry in Mumbai Area has undergone since the inception (2006) of the existing Standby Arrangement;*
- c) *Allocate the Standby Charges among the various beneficiaries in the Mumbai distribution network including the deemed distribution licensees and the captive and open access consumers;*
- d) *Reduce the total quantum of the Standby Charges being levied on the beneficiaries to the extent of allocation as per prayer (c) above;*
- e) *Condone any inadvertent omissions / errors / shortcomings in the Petition;*
- f) *Allow to add / change / modify / alter this filing and make further submissions as may be required at a future date; and*
- g) *Issue any other directions it deems fit and proper.*

I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized Consumer Representatives on **Tuesday, 16 May, 2017 at 11.30 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to serve immediately, a copy of its above Petition (both in soft and hard copy) to the Respondents and the authorized Institutional Consumer Representatives.

4. The Respondents are directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and the authorized Institutional Consumer Representatives.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible, and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
