Subject: Petition of Baby Mohan Teli & 3 Others regarding compensation for Transmission works on his land as per-Section 67 (4) of the EA, 2003 and Rule 3(3) of Maharashtra Electricity Works of Licensees Rules, 2012.

- **Case No. 69 of 2017**

Baby Mohan Teli & 3 Others has filed a Petition on 26.04.2017 regarding compensation for Transmission works on his land as per-Section 67 (4) of the EA, 2003 and Rule 3(3) of Maharashtra Electricity Works of Licensees Rules, 2012.

The main prayers of the Petitioner are as under-

- 1) *By allowing this revision, the opponent no. 3/Licensee company may kindly be directed to pay amount of Rs. 01,30,00,000/- or as per prescribed law/rules, towards compensation as per The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 to applicants.*
- 2) *Alternately Licensee company may kindly be directed to pay amount compensation for damages of Rs. 50,00,000/- towards permanent diminution in value of applicants' land and annual rent of Rs.50,000/-.*
- 3) *Interim Orders may kindly be passed pending this revision.*
- 4) *Cost of revision may kindly be imposed on opponents.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized Consumer Representatives on **Tuesday, 23 May, 2017 at 11.30 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to serve immediately, a copy of its above Petition (both in soft and hard copy) to the Respondents and the authorized Institutional Consumer Representatives.

4. The Respondents are directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and the authorized Institutional Consumer Representatives.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible, and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
