Subject: Petition of Sai Wardha Power Generation Limited under Section 42 and other applicable provisions of the EA, 2003 for directions to the Respondent in regard to the terms of Open Access granted by the Respondent MSEDCL for the period from 01.04.2017 and in regards to retrospective cancellation of short term open access for the month on March, 2017.

- **Case No. 76 of 2017**

Sai Wardha Power Generation Limited has filed a Petition on 05.05.2017 under Section 42 and other applicable provisions of the EA, 2003 for directions to the Respondent in regard to the terms of Open Access granted by the Respondent MSEDCL for the period from 01.04.2017 and in regards to retrospective cancellation of short term open access for the month on March, 2017.

The main prayers of the Petitioner are as under-

(a) *Quash the retrospective cancellation of the short term open access for the period from 23/03/2017 to 31/03/2017 for supply the Petitioner to the Respondents No. 1 to 6 and quash any consequent action taken by MSEDCL including re-allocation of such power supplied by the Petitioner to Respondents No. 1 to 6;*

(b) *Hold and direct that the reduction of quantum of short-term open access and non-approval of short-term open access for supply by the Petitioner to Respondents No. 3 to 9 on account of alleged metering system constraints is illegal, incorrect;*

(c) *Pass urgent interim orders for grant of short term open access for the full quantum of short term open access applied for by the Petitioner for supply to its consumers subject to the total drawal by the consumers from all sources shall not exceed the contract demand and the metering system capacity;*

(d) *Award costs of the present proceedings; and*

(e) *Pass such other further orders as the Hon'ble Commission may deem just in the facts of the present case.*

2. I am directed to communicate that a hearing in the matter will be held in the presence of authorised consumer representatives on **Tuesday, 16 May, 2017 at 11.30 hrs** in the office of the Commission at 13th Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Commission has implead MSETCL as party in the matter.

4. The Petitioner is directed to serve, a copy of its above Petition (both in soft and hard copy) to the Respondents, the authorized Institutional Consumer Representatives and to the implead MSETCL before the scheduled date of hearing.

5. The Respondents are directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner, authorized Institutional Consumer Representatives and implead MSETCL well in advance.

6. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible, and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
