Subject: Miscellaneous Application filed by applicant Sai Wardha Power Generation Limited for Interim relief in Case No. 62 of 2017 for stay and restrain MSEDCL from revising the permission of MTOA granted under Section (9) of EA, 2003

- **MA No. 9 of 2017 Case No. 62 of 2017**

Sai Wardha Power Generation Limited has filed Miscellaneous Application on 08.05.2017 for Interim relief in Case No. 62 of 2017 for stay and restrain MSEDCL from revising the permission of MTOA granted under Section (9) of EA, 2003.

The main prayers of the Petitioner are as under-

(a) *Pass an ex-parte ad-interim order for stay to restrain MSEDCL from revising the permissions of medium term open access granted under section (9) of EA 2003 as mentioned vide their letter dated 26/04/2017 and refrain from any levy CSS, Additional Surcharge and any other charges, which are not leviable on captive consumption, in the monthly invoice of April, 2017 and subsequent invoices to be raised after the end of each month;*

(b) *Pass such other further order(s) as the Hon'ble Commission may deem just in the facts of the present case.*

2. I am directed to communicate that a hearing in the matter will be held in the presence of authorised consumer representatives on **Tuesday, 16 May, 2017 at 11.30 hrs** in the office of the Commission at 13th Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

4. The Respondents are directed to submit their say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Application, with a copy to the Applicant and the authorized Institutional Consumer Representatives.

5. The Parties are directed to file their Application/Petition and submissions in MS -Word file and PDF version as far as possible, and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
