Subject: Petition of Dhariwal Infrastructure Limited, under MERC (Conduct of Business) Regulations, 2004 seeking relief to idle State Grid-connected Unit 1 of 2x300MW Coal based thermal generating station located at Tadali, Chandrapur in the State of Maharashtra through short-term sale of power to any State Distribution Licensee for a period of 3 months in FY 2017-18.

- **Case No. 61 of 2017**

Petitioner has filed this Petition on 21.04.2017 under MERC (Conduct of Business) Regulations, 2004 seeking relief to idle State Grid - connected Unit 1 of 2x300MW Coal based thermal generating station through short - term sale of power to any State Distribution Licensee for a period of 3 months in FY 2017-18.

The main prayers of the Petitioner are as under-

- a) *admit the petition;*
- b) *allow the Petitioner to check the readiness of Unit 1 of 2 x 300 MW Coal based thermal generating station of Dhariwal Infrastructure Limited located at Tadali, Chandrapur in the State of Maharashtra through sale of power to any State Distribution Licensee on short-term basis for a period of about 3 months during the impending summer season in FY 2017-18 at a competitive rate and as approved by this Hon'ble Commission;*
- c) *condone any inadvertent omissions/errors/rounding-off differences/shortcomings and permit the Petitioner to add/alter this filing and make further submissions as may be required in future; and*
- d) *pass such other Order/s, as this Hon'ble Commission may deem fit and proper, keeping in view the facts and circumstances of the case.*

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible, and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
