Subject: Petition of Shah Promoters and Developers, under Section 86(1)(f) of the EA,2003 pertaining to adjudication of disputes between Shah Promoters & Developers and MSEDCL.

- Case No. 73 of 2017

Shah Promoters and Developers has filed a Petition on 27.04.2017 under Section 86(1) (f) of the EA, 2003 pertaining to adjudication of disputes between Shah Promoters & Developers and MSEDCL.

The main prayers of the Petitioner are as under-

- (a) Direct the Respondent to make payment for the wind energy generated by the Petitioner regularly and in timely manner as per all the WEPAs;
- (b) Direct MSEDCL to make payment of the Outstanding Amount towards Sales Invoices due till date immediately [a sum of Rs. 13,81,02,672/- (Rupees Thirteen Crores Eighty One Lakhs Two Thousand Six Hundred and Seventy Two Only) for the project to the tune of 11.2 MW and a sum of Rs. 75,98,334/- (Rupees Seventy Five Lakhs Ninety Eight Thousand Three Hundred and Thirty Four Only) for the project to the tune of 0.8 MW are due as on April 15, 2017 as detailed in Annex D];
- (c) Direct MSEDCL to make payment of the Outstanding Amount towards DPC as per the WEPAs immediately [a sum of Rs. 2,13,21,794/- (Rupees Two Crores Thirteen Lakhs Twenty One Thousand Seven Hundred and Ninty Four Only) for the project to the tune of 11.2 and a sum of Rs. 12,15,511/- (Rupees Twelve Lakhs Fifteen Thousand Five Hundred and Eleven Only) is outstanding towards delayed payment surcharge for the project to the tune of 0.8 MW are outstanding DPC as on April 15, 2017 is also detailed in Annex D];
- (d) Direct the Respondent to pay carrying cost at the rate of 15% per annum of the delay in payment of the late/delayed payment surcharge by the Respondent;
- (e) Direct Respondent to comply with the terms of WEPAs in letter and spirit by making payments thereunder within stipulated time;
- (f) Direct Respondent to issue credit notes within fifteen (15) days generation and comply with the Citizen Charter to enable the Petitioner to issue invoices under the WEPAs in a timely manner:
- (g) Award costs of these proceedings against MSEDCL and in favour of the Petitioner; and
- (h) Pass such other order(s) as the Hon'ble Commission may deem just in the facts of the present case.
