4. The Original Petitioner and the Respondent are directed to submit well in advance the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Application, with a copy to the Applicant and authorized Consumer Representatives.

5. The Parties are directed to file their Application/Petition and submissions in MS -Word file and PDF version as far as possible, and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
