The main prayers of the Petitioner are as under-

- a) *Pass an ad-interim ex-parte order of directing MSEDCL to forthwith issue NOC for STOA for the month of June 2017;*
- b) *Pass an ad-interim ex-parte order of directing MSEDCL to not raise such issue for denying open access as far as Applicant is ready to undertake that total drawl shall not exceed MSEDCL contract demand;*
- c) *Confirm the ex-parte orders after notice to MSEDCL;*
- d) *Direct MSEDCL to issue NOC for MTOA from the month of July 2017 to March 2018 on the basis of application made on February 28, 2017;*
- e) *Award costs of the present proceedings; and*
- f) *Pass such other further order(s) as the Hon'ble Commission may deem just in the facts of the present case.*
