- c) Direct to pay all amounts outstanding to the Petitioner towards partial sale till date as detailed in clause *Error! Reference source not found.*above;
- d) Direct MSEDCL to pay to the Petitioner towards over injected units at the end of each financial year as detailed in clause **Error!
