PUBLIC NOTICE

Suggestions / objections on The Tata Power Company Limited - Distribution Business' Petition for revision of Service Connection Charges. (Case No. 82 of 2017)

The Tata Power Company Limited's Distribution Business (Tata Power-D) has filed a Petition for revision of Service Connection Charges under MERC (Electricity Supply Code and Other Conditions of Supply) Regulations, 2005 before the Maharashtra Electricity Regulatory Commission.

The Commission has admitted the Petition on 28 August, 2017 and directed Tata Power -D to publish a Public Notice under Section 64(2) of the Electricity Act, 2003 inviting Suggestions /Objections from the public.

The Commission had approved the Schedule of Charges to be recovered from the consumers of Tata Power-D vide its Order dated 28th December, 2012 in Case No. 47 of 2012 and Order dated 26 June, 2015 in Case No. 18 of 2015

A meeting was held with Govt. of Maharashtra on 9th May 2017 with respect to "Doing Business in India-Getting Electricity" Reduction of Service Connection Charges to reduce the cost of getting new electricity connections (upto 150 kVA) to 25% of national per capita income was one of the agenda in this discussion.

There is a significant difference in the Service Connection Charges of parallel Distribution Licensees in Mumbai which is not only impacting the competitiveness of Tata Power-D, but burdening its consumers. Hence, Tata Power-D has filed the present Petition for revision of its 'Schedule of Charges'.
