The main prayers of the Applicant are as under-

*a. allow all the reliefs claimed by the Petitioner in the above main Petition.*

*b. set aside the notice dated 14.08.2017 issued by the MSEDCL, Respondent claiming the alleged differential amount of Rs.31,86,504.92.*

*c. set aside the energy bill dated 01.09.2017 for the month of August 2017 to the extent it demands alleged amount of Rs.32,26,327.48 claiming as principle arrears apparently based on the aforesaid notice dated 14.08.2017.*

*d. pending the hearing and final disposal of the above Petition, the aforesaid notice dated 14.08.2017 be stayed.*

*e. pending the hearing and final disposal of the above Petition, the aforesaid energy bill dated 01.09.2017 to the extent of amount of Rs.32,26,327.48 be stayed.*

*f. to pass such other and further order and/or issue direction in favour of the Petitioner as may be suitable in the facts and circumstances.*
