Subject: Petition filed by Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL) for approval for Amendment in the Model Bidding Documents issued by Ministry of Power for Procurement of electricity for medium term from power stations set up on Finance, Own and Operate basis on January 16, 2017

- **Case No. 144 of 2017**

Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL) has submitted a Petition on 10.10.2017, under Section 86 (1) (b) of Electricity Act, 2003 for approval for Amendment in the Model Bidding Documents issued by Ministry of Power for Procurement of electricity for medium term from power stations set up on Finance, Own and Operate basis on January 16, 2017

The main prayers of the Petitioner are as under-

- a. *To admit the Petition as per the provisions of Regulation 86(1)(b) of the Electricity Act, 2003;*
- b. *To direct BEST to extend the bid submission till such time the instant Petition is decided;*
- c. *To direct BEST to make suitable amendments in the captioned tender for medium term power procurement for 750 MW so as to allow deemed traders like MSEDCL to participate in the tender;*
- d. *To direct BEST to provide clear and unambiguous response to the queries raised during the pre-bid meeting*
- e. *To pass any other order/relief as the Hon'ble Commission may deem fit and appropriate under the circumstances of the case and in the interest of justice;*
- f. *To condone any error/omission and to give opportunity to rectify the same;*
- g. *To permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time.*

The interim application prayers of the Petitioner are as under-

- a. *MSEDCL therefore humbly prays that this Hon'ble Commission may graciously be pleased to allow this application; and:*

- b. *Stay the operation of the Bidding Process of BEST till the disposal of the accompanying Petition;*
- c. *pass any other order/ orders as this Hon'ble Commission may deem fit and proper in the facts and circumstances of the case as well as in the interests of justice.*

I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Monday, 16 October, 2017 at 11.30 hrs** in the office of the Commission at 13<sup>th</sup> Floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.
4. The Petitioner is directed to serve immediately; a copy of it's above Petition (in soft and hard copy) to the Respondent and authorized Consumer Representatives.
5. The Respondent is directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner and authorized Consumer Representatives.
6. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible, and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
