Subject: Petition of Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) to review the Daily Order dated 14.12.2017 passed in Case No. 180 of 2017.

- **Case No. 205 of 2017**

MSEDCL has submitted a Petition on 21.12.2017, under Section 94 of the Electricity Act, 2003 to review of daily order dated 14.12.2017 passed in Case No. 180 of 2017 Petition filed by OPGS Power Gujarat Private Limited against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for wrongful imposition of CSS and Additional Surcharge on the captive users of OPGS availing Open Access for the FYs 2015-16 and 2016-17 & Quash the letter issued by MSEDCL dated 28.11.2017.

The main prayers of the Petitioner are as under-

- a) *Review its daily order dated 14.12.2017 to the limited extent as challenged by MSEDCL.*
- b) *Vacate the directions of “No coercive action” given to MSEDCL vide order dated 14.12.2017.*
- c) *In the alternative, impose mandatory conditions on OPGS for availing any “No coercive action”*
- d) *Pass such further orders as deemed fit and proper in the interest of justice and good conscience.*

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
