Subject: Petition filed by M/s. Gurera Synthetics Pvt. Ltd., under Sections 45(5), 50, 62(6), 86(1) and 94(1) (g) of the Electricity Act, 2003, for the alleged violation of the provisions of the said act, the rules and regulations framed thereunder and specially in violation of the Regulation No. 15.4 “Billing in the Event of Defective meters” of MERC (Electricity supply code and other conditions of Supply) Regulations, 2005.

- **Case No. 134 of 2017**

M/s. Gurera Synthetics Pvt. Ltd., has filed an amended Petition on 21.12.2017 under Sections 45(5), 50, 62(6), 86(1) and 94(1) (g) of the Electricity Act, 2003, for the alleged violation of the provisions of the said act, the rules and regulations framed thereunder and specially in violation of the Regulation No. 15.4 “Billing in the Event of Defective meters” of MERC (Electricity supply code and other conditions of Supply) Regulations, 2005.

2. *MSEDCL be directed to strict compliance of Maharashtra Electricity Regulatory Commission (Electricity supply code and other conditions of Supply) Regulations, 2005 Regulation No. 15.4 Billing in the Event of Defective meters in the matter of assessment in meter fault.*
3. *The Hon’ble Commission be pleased to pass such other orders as this Hon’ble Commission may deem fit.*
4. *Permission may be granted to correct the Petition if necessary.*
