Subject:- Petition of Royal Embroidary Threads P. Ltd against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for Non-compliance of CGRF Baramati Zone Order and MERC Order in Case No. 78 of 2016 dated 13.07.2017.

Royal Embroidary Threads P. Ltd has filed a Petition on 18.12.2017 under Section 62 (6), 142 & 146 of the Electricity Act, 2003 against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for Non-compliance of CGRF Baramati Zone Order and MERC Order in Case No. 78 of 2016 dated 13.07.2017.

The main prayers of the Petitioner are as under-

- a) *Invocation of section 142 & 146 of Electricity Act 2003 for non compliance of CGRF order & non implementation of ACT, Rules & regulations.*
- b) *Refund **Rs. 4,81,989.86** against CGRF order as per refund statement to be credited in H T consumer no. 173279 043 960 of Royal Embroidary Threads P. Ltd*
- c) *Interest is payable by MSEDCL from the date of payment till date of refund in consumer's account.*
- d) *The cost of the petition to the petitioner.*
