Subject:- Miscellaneous Application filed by Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL) for Impleadment in Case No. 176 of 2017 Petition filed by BEST Undertaking U/S 86 (1) (b) of EA, 2003 to regulate electricity purchase and procurement process of distribution licensees including the price at which electricity shall be procured from the generating companies or licensees or from other sources through agreements for purchase of power for distribution and supply within the State.

The Applicant MSEDCL has submitted an Application on 03.01.2018 for Impleadment in Case No. 176 of 2017 Petition filed by BEST Undertaking U/S 86 (1) (b) of EA, 2003 to regulate electricity purchase and procurement process of distribution licensees including the price at which electricity shall be procured from the generating companies or licensees or from other sources through agreements for purchase of power for distribution and supply within the State.

The main prayers of the Petitioner are as under-

1 To admit the present Application and allow MSEDCL to implead as a party in the present petition.

2 To direct M/s BEST to procure power @ rate discovered through E-bidding process carried out in tender BEST/Medium/Lump sum Tariff/17-18/ET/57.

3 In case Hon'ble Commission decides to allow for procurement of power to M/s. BEST for 6 months after expiry of the existing PPA, then provide an opportunity to offer sale of power to M/s. BEST in-stead of unilateral extension to the existing expiring PPA.

4 To consider the submission made by the Petitioner and consider the same positively while deciding the Petition;

5 To condone any error/omission and to give opportunity to rectify the same;

6 To permit the Petitioner to make further submissions, addition and alteration to this Petition as may be necessary from time to time.

2. I am directed to communicate that a hearing in the matter will be held in the presence of authorised consumer representatives on **Thursday, 18 January, 2018 at 11.00 hrs** in the office of the Commission at 13th Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

5. The Original Petitioner and Respondent are directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition from receipt of copy of Petition, with a copy to the Applicant and the authorized Consumer Representatives.
6. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible, and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
