Subject:- Petition of SVP Packing Industry Pvt. Ltd against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for non-compliance of the CGRF, Kalyan, Order No. K/E/958/ 1164/2015-16 dated 1.9.2017 and MERC Order in Case No. 78 of 2016 dated 13.07.2017.

- **Case No. 02 of 2018**

SVP Packing Industry Pvt. Ltd has filed a Petition on 26.12.2017 under Section 142 & 146 of the Electricity Act 2003 against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for non-compliance of CGRF, Kalyan, and Order K/E/941/1147/2015-16 dated 1.9.2017 and MERC Case No. 78 of 2016 dated 13.07.2017.

The main prayers of the Petitioner are as under-

- a) *Invocation of section 142 & 146 of Electricity Act 2003 for non compliance of CGRF order no 1164, MERC case no 78 & non implementation of ACT, Rules & Regulations.*
- b) *Refund AEC, Addl FAC prematurely & wrongly recovered amount Plus FAC excess recovered amount with interest @ 9 % up to Sept' 2017, Rs. 3,94,287.90 including duty and interest on FAC to be credited to same consumer name shifted to Palghar circle H T consumer no. 003659 041 410. (Earlier consumer no. of Vasai circle 001849 032870) by name SVP Packing Industry P. Ltd. as per Order of CGRF.*
- c) *Interest on entire refund amount from 30 days of CGRF orders dt 1 Sept' 2017 for non compliance till the date of credit of amount in consumer's account as per Sec 62 (6) of E A 2003.*
- d) *The cost of the petition to the petitioner.*

2. 4. The Respondents are directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner and authorized Consumer Representatives.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
