Ambernath Paper Mills Pvt. Ltd. has filed a Petition on 26.12.2017 under Section 142 & 146 of the Electricity Act 2003 against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for non-compliance of the CGRF, Kalyan, and Order No. K/E/962/1168/2015-16 dated 01.09.2017 and MERC Order in Case No. 78 of 2016 dated 13.07.2017.

The main prayers of the Petitioner are as under-

- a) *Invocation of section 142 & 146 of Electricity Act 2003 for non compliance of CGRF order & non implementation of ACT, Rules & regulations.*
- b) *Refund **Rs. 5,74,185.61** against CGRF order as per refund statement to be credited in H T consumer no. 021529 050 930 of Ambernath paper Mills P. Ltd*
- c) *Interest is payable by MSEDCL from the date of payment till date of refund in consumer's account.*
- d) *The cost of the petition to the petitioner.*
