Ltd ( Savex seals merged in SVP Packaging as per Hon. High court order ) which is now shifted to Palghar circle H T consumer no. 003659 041 410. (Earlier consumer no. of Vasai circle 001849 031 730) by name Savex Seals P. Ltd. as per Order of CGRF.
- c) Interest on entire refund amount from 30 days of CGRF order dt 1 Sept' 2017 for non compliance till the date of credit of amount in consumer's account as per Sec 62 (6) of E A 2003.
