- **Case No. 08 of 2018**

Vista packaging Pvt. Ltd. has filed a Petition on 26.12.2017 under Section 142 & 146 of the Electricity Act 2003 against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for non-compliance of the CGRF, Kalyan, Order No. K/E 1) 1114//1335/, 2) 1123/1344 3) 1140/1362, 4) 1131/1353 dated 23.08.2017, 18.08.2017, 23.08.2017 & 14.09.2017 respectively , and MERC Order in Case No. 78 of 2016 dated 13.07.2017.

The main prayers of the Petitioner are as under-

a) *Invocation of section 142 & 146 of Electricity Act 2003 for non compliance of 4 CGRF orders & non implementation of ACT, Rules & Regulations.*

b) *Refund AEC, Addl FAC prematurely & wrongly recovered amount Plus FAC excess recovered amount with interest @ 9 % up to Sept' 2017, Rs. 1,42,644.27 including interest on FAC to be credited in H T consumer no. 001849 031 210 of Vista packaging P. Ltd. as per 4 orders of CGRF.*

c) *Interest on entire refund amount from 30 days of respective CGRF orders non compliance till the date of credit of amount in consumer's account as per Sec 62 (6) of E A 2003.*

d) *The cost of the petition to the petitioner.*

4. The Respondent is directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner and authorized Consumer Representatives.
