- **b)** Refund AEC, Addl FAC prematurely & wrongly recovered amount Plus FAC excess recovered amount with interest @ 9 % up to Sept' 2017, Rs. 5,83,077.14 including duty and interest on FAC by RTGS since Consumer is permanently disconnected (HT consumer no. 003019 033 690) In bill of Oct' 17, consumer has received credit of Cr Rs. 3,63,091.15 but details are not provided & RTGS not yet done. Action is awaited from MSEDCL.
- c) Interest on entire refund amount from 30 days of CGRF order dt 1 Sept' 2017 for non compliance till the date of credit of amount in consumer's account as per Sec 62 (6) of E A 2003.
- *d)* The cost of the petition to the petitioner.
