Subject:- Petition of First Winner Lifestyles Ltd. Plot No.C-8/1 against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for non-compliance of the CGRF, Kalyan Order No. 1171 dated 01.09.2017 and MERC Order in Case No. 78 of 2016 dated 13.07.2017.

**Case No. 15 of 2018**

First Winner Lifestyles Ltd. Plot No.C-8/1 has filed a Petition on 27.12.2017 under Section 142 & 146 of the Electricity Act 2003 against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for non-compliance of the CGRF, Kalyan Order No. 1171 dated 01.09.2017 and MERC Order in Case No. 78 of 2016 dated 13.07.2017.

The main prayers of the Petitioner are as under-

- a) Invocation of section 142 & 146 of Electricity Act 2003 for non compliance of CGRF order no 1164, MERC case no 78 & non implementation of ACT, Rules & Regulations.
- b) Refund AEC, Addl FAC prematurely & wrongly recovered amount Plus FAC excess recovered amount with interest @ 9 % up to Sept' 2017, **Rs. 4,10,878.71** including duty and interest on FAC by RTGS since Consumer is permanently disconnected ( H T consumer no. 003019 031 470 ) In bill of Oct' 17, consumer has received credit of **Cr Rs. 2,02,263.28** but details are not provided & RTGS not yet done. Action is awaited from MSEDCL.
- c) Interest on entire refund amount from **30 days of CGRF order dt 1 Sept' 2017** for **non compliance** till the date of credit of amount in consumer's account as per Sec 62 ( 6 ) of E A 2003.
- d) *The cost of the petition to the petitioner.*

2. 4. The Respondents are directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner and authorized Consumer Representatives.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
