Subject:- Petition of R. P. Industries against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for non-compliance of the CGRF, Kalyan, Order No. 1154 dated 01.09.2017 and MERC Order in Case No. 78 of 2016 dated 13.07.2017.

- **Case No. 23 of 2018**

R. P. Industries has filed a Petition on 01.01.2018 under Section 142 & 146 of the Electricity Act 2003 against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) ) for non-compliance of the CGRF, Kalyan, Order No. 1154 dated 01.09.2017 and MERC Order in Case No. 78 of 2016 dated 13.07.2017.

The main prayers of the Petitioner are as under-

- a) *Invocation of section 142 & 146 of Electricity Act 2003 for non compliance of CGRF order no 1154, MERC case no 78 & non implementation of ACT, Rules & Regulations.*
- b) *Refund AEC, Addl FAC prematurely & wrongly recovered amount Plus FAC excess recovered amount with interest @ 9 % up to Sept' 2017, **Rs. 1,09,061.64** to be credited in consumer no. **001849 030 040 R. P. Industries** as per Order of CGRF.*
- c) *Interest on entire refund amount from **30 days of CGRF order dt 1 Sept' 2017** for **non compliance** till the date of credit of amount in consumer's account as per Sec 62 ( 6 ) of E A 2003.*
- d) *The cost of the petition to the petitioner.*
