Subject:- Petition of R. P. Industries against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for non-compliance of the CGRF, Kalyan, Order 1145 dated 01.09.2017 and MERC Order in Case No. 78 of 2016 dated 13.07.2017.

- **Case No. 24 of 2018**

R. P. Industries has filed a Petition on 02.01.2018 under Section 142 & 146 of the Electricity Act 2003 against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for non-compliance of the CGRF, Kalyan, Order 1145 dated 01.09.2017 and MERC Order in Case No. 78 of 2016 dated 13.07.2017.

The main prayers of the Petitioner are as under-

- a) *Invocation of section 142 & 146 of Electricity Act 2003 for non compliance of CGRF order no 1144, MERC case no 78 & non implementation of ACT, Rules & Regulations.*
- b) *Refund AEC, Addl FAC prematurely & wrongly recovered amount Plus FAC excess recovered amount with interest @ 9 % up to Sept' 2017, Rs. 4,64,999.70 including duty and interest on FAC to be credited in H T consumer no. 001849 022 950 M/s. R. P. Industries as per Order of CGRF.*
- c) *Interest on entire refund amount from 30 days of CGRF order dt 1 Sept' 2017 for non compliance till the date of credit of amount in consumer's account as per Sec 62 ( 6 ) of E A 2003.*
- d) *The cost of the petition to the petitioner.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Tuesday, 23 January, 2018 at 11.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent and authorised consumer representatives before the scheduled date of hearing.

4. The Respondent is directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner and authorized Consumer Representatives.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
