Subject:- Petition of Bhulani Steel against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for non-compliance of the CGRF, Kalyan, Order No. 1151/2015-16 dated 01.09.2017 and MERC Order in Case No. 78 of 2016 dated 13.07.2017.

- **Case No. 26 of 2018**

Bhulani Steel has filed a Petition on 26.12.2017 under Section 142 & 146 of the Electricity Act 2003 against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for non-compliance of the CGRF, Kalyan, Order No. 1151/2015-16 dated 01.09.2017 and MERC Order in Case No. 78 of 2016 dated 13.07.2017.

The main prayers of the Petitioner are as under-

- a) *Invocation of section 142 & 146 of Electricity Act 2003 for non compliance of CGRF order no 1151, MERC case no 78 & non implementation of ACT, Rules & Regulations.*
- b) *Refund AEC, Addl FAC prematurely & wrongly recovered amount Plus FAC excess recovered amount with interest @ 9 % up to Sept' 2017, **Rs. 4,39,448** including duty and interest on FAC. Consumer received **debit adj. of Rs. 59,585.44 in Oct' 17 bill & credit of Rs. 90,562.81 in bill of November' 17.** Details not provided. Total amount to be credited to H T consumer no. 003729 39 120 by name Bhulani Steel as per Order of CGRF.*
- c) *Interest on entire refund amount from **30 days of CGRF order dt 1 Sept' 2017 for non compliance** till the date of credit of amount in consumer's account as per Sec 62 ( 6 ) of E A 2003.*
- d) *The cost of the petition to the petitioner.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Tuesday, 23 January, 2018 at 11.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

4. The Respondents are directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner and authorized Consumer Representatives.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
