Subject:- Joint Petition of 1) Reliance Infrastructure Limited and 2) Reliance Electric Generation and Supply Limited seeking approval to assign the distribution licence granted to the 1st Petitioner and the transfer of assets of the distribution system of the 1<sup>st</sup> Petitioner to the 2<sup>nd</sup> Petitioner.

And

Addendum Petition to implead Adani Transmission Limited as Respondent in Case No 140 of 2017, approve transfer of 100% stake of 1<sup>st</sup> Petitioner in 2<sup>nd</sup> Petitioner to Respondent.

**Case No. 140 of 2017**

The Petitioner has filed Addendum Petition on 05.01.2018 in the Joint Petition filed by 1) Reliance Infrastructure Limited and 2) Reliance Electric Generation and Supply Limited under Section 17 (3) of the Electricity Act, 2003; and In the matter of Regulation 8.3.10 of MERC (General Conditions of Distribution Licence) Regulations, 2006, seeking approval to assign the distribution licence granted to the 1st Petitioner and the transfer of assets of the distribution system of the 1st Petitioner to the 2nd Petitioner.

The Petitioner additionally prays are as under-

- a. *implead Adani Transmission Limited as Respondent in Case No 140 of 2017*
- b. *approve transfer of 100% stake of 1<sup>st</sup> Petitioner in 2<sup>nd</sup> Petitioner to Respondent*
- c. *allow the 1<sup>st</sup> Petitioner to retain four plots of land (as mentioned above in paragraph 6) valued at Rs 250 Crore*
- d. *hold that 1<sup>st</sup> Petitioner is entitled to receive from the 2nd Petitioner and is liable to pay to 2<sup>nd</sup> Petitioner, all such amounts as may become so receivable or payable in respect of past claims in respect of the licensed business, as per para 9 above*
- e. *for such further and other reliefs as the nature and circumstances of the case may require*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Monday, 05 February, 2018 at 10.30 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioners are directed to immediately serve a copy of its above mentioned Addendum Petition (both in soft and hard Copy) to the Respondent and authorised consumer representatives before the scheduled date of hearing.

4. The Respondent is directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Addendum Petition immediately, with a copy to the Petitioners and authorized Consumer Representatives (CR), the CRs may submit there say before hearing.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
