Riddhi Siddhi Gluco Biols Limited has filed a Petition on 08.01.2018 under Section 86(1)(f) of the EA, 2003 against MSEDCL in the matter of recurring non-payment and/or late payment of the principal amounts as well as non-payment of Late Payment Surcharge on the delayed payment under the Wind Energy Purchase Agreement Dated 17<sup>th</sup> June 2011.

The main prayers of the Petitioner are as under-

- a. Direct the Respondent No. 1-MSEDCL to make payment of the outstanding amount of Rs. 33,91,075 /- [Rupees Thirty Three Lakhs Ninety One Thousand Seventy Five only], payable towards late payment surcharge for delayed payment of the monthly energy bills of the Petitioner, in accordance with Clause 11.04 of the Wind Energy Purchase Agreement dtd. 17<sup>th</sup> June 2011 entered into with the Respondent No. 1, and the same be done within 7 days;
- b. Further direct the Respondent No. 1-MSEDCL to make payment of an amount of Rs. 2,02,48,389 /- [Rupees Two Crores Two Lakhs Forty Eight Thousand Three Hundred Eighty Nine only] towards the unpaid/uncleared monthly energy bills of the Petitioner, in accordance with the Wind Energy Purchase Agreement dtd. 17<sup>th</sup> June 2011 entered into with the Respondent No. 1, and the same be done within 7 days;
- c. Direct the Respondents to pay interest @ 18% p.a. on the late payment surcharge, till date;
- d. Costs of the present petition may kindly be provided for.
