Subject: Petition of OPGS Power Gujarat Private Limited against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) against order dated 29.12.2017 passed by the MERC, in terms of the Order dated 09.01.2018 passed by the Appellate Tribunal in Appeal No. 03 of 2018.

- **Case No. 48 of 2018**

OPGS Power Gujarat Private Limited has submitted a Petition on 17.01.2018, under Section 94(1)(f) of the Electricity Act, 2003 against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) against order dated 29.12.2017 passed by the MERC, in terms of the Order dated 09.01.2018 passed by the Appellate Tribunal in Appeal No. 03 of 2018.

The main prayers of the Petitioner are as under-

- a) *Review the Order dated 29.12.2017 in terms stated in the present Review Petition;*
- b) *Adjudicate Case No.180 of 2017 on merits; and*
- c) *Pass such other and further order or orders of this Hon'ble Commission deems fit and proper under the facts and circumstances of the present case.*

**The Petitioner has filed the Interlocutory Application dated 17.01.2018 alongwith Review Petition seeking appropriate directions for Interim Relief and prays for:**

- a) *Continue the interim protection granted by the Hon'ble Appellate Tribunal in favour of the Review Petitioner which is expiring on 23.01.2018, till the pendency of the accompanying review petition and the underlying Case No.180 of 2017;*
- b) *Direct the Respondent not to take any coercive measure, whatsoever, including stoppage/withholding of open access approval under section 9 of the Electricity Act, 2003 for upcoming months in the current financial year and thereafter; and*
- c) *Pass such other and further order or orders as this Hon'ble Commission deems fit and proper under the facts and circumstances of the present case.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Tuesday, 23 January, 2018 at 12.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent and the authorised consumer representatives before the scheduled date of hearing.

4. The Respondent is directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner and authorized Consumer Representatives (CR), The CRs may submit there say before hearing.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
