Subject:- Petition of Bharat Rubber Works Pvt. Ltd. against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for non-compliance of the CGRF, Kalyan, Order No.1370/1377/1391/1384 dated 10.08.17,18.08.17,23.08.17,14.09.17 respectively and MERC Order in Case No. 78 of 2016 dated 13.07.2017.

- **Case No. 30 of 2018**

Bharat Rubber Works Pvt. Ltd. has filed a Petition on 10.01.2018 under Section 142 & 146 of the Electricity Act 2003 against Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) for non-compliance of the CGRF, Kalyan, Order No.1370/1377/1391/1384 dated 10.08.17, 18.08.17, 23.08.17, 14.09.17 respectively and MERC Order in Case No. 78 of 2016 dated 13.07.2017.

The main prayers of the Petitioner are as under-

- a) *Invocation of section 142 & 146 of Electricity Act 2003 for non compliance of 4 CGRF orders & non implementation of ACT, Rules & Regulations.*
- b) *Refund AEC, Adtl FAC prematurely & wrongly recovered amount Plus FAC excess recovered amount with interest @ 9 % up to Sept' 2017, **Rs. 4,04,540.54** including interest on FAC to be credited in H T consumer no. 001849 029 000 of Bharat Rubber Works P. Ltd. as per 4 orders of CGRF.*
- c) *Interest on entire refund amount from **30 days of respective CGRF orders non compliance** till the date of credit of amount in consumer's account as per Sec 62 (6) of E A 2003.*
- d) *The cost of the petition to the petitioner.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Friday, 02 February, 2018 at 10.30 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondent and authorised consumer representatives before the scheduled date of hearing.

4. The Respondent is directed to submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition immediately, with a copy to the Petitioner and authorized Consumer Representatives (CR), The CRs may submit there say before hearing.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
