- b) Refund AEC, Addl FAC prematurely & wrongly recovered amount Plus FAC excess recovered amount with interest @ 9 % up to Sept' 2017, Rs. 2,45,126.65 including duty and interest on FAC and Rs. 16,881.23 recovered as debit bill adjustment in feb' 2017 bill to be credited in H T consumer no. 001849 026 420 Infra Industries as per Order of CGRF.
- *c)* Interest on entire refund amount from 30 days of CGRF order dt 1 Sept' 2017 for non compliance till the date of credit of amount in consumer's account as per Sec 62 ( 6 ) of E A 2003.
- *d*) *The cost of the petition to the petitioner.*
