- *c)* Interest on entire refund amount from 30 days of CGRF order dt 1 Sept' 2017 for non compliance till the date of credit of amount in consumer's account as per Sec 62 ( 6 ) of E A 2003.
- *d)* The cost of the petition to the petitioner.
