- b) Refund AEC, Addl FAC prematurely & wrongly recovered amount Plus FAC excess recovered amount with interest @ 9 % up to Sept' 2017, **Rs. 1,24,548.90** including interest on FAC to be credited in H T consumer no. 001849 039 610 of Bharat Plastopack P. Ltd. as per 4 orders of CGRF.
- *c)* Interest on entire refund amount from 30 days of respective CGRF orders non compliance till the date of credit of amount in consumer's account as per Sec 62 ( 6 ) of E A 2003.
- *d)* The cost of the petition to the petitioner.
