Mega Rubber Technologies P. Ltd. as per Order of CGRF.
- c) Interest on entire refund amount from 30 days of CGRF order dt 1 Sept' 2017 for non compliance till the date of credit of amount in consumer's account as per Sec 62 (6) of E A 2003.
- d) The cost of the petition to the petitioner.
