Ltd., for the IT & ITeS SEZ at Survey No. 65 (p), Kharadi, Tal Haveli, Dist Pune, and for issuing the Specific Conditions of Distribution Licence applicable to the Petitioner.

- **Case No. 75 of 2018**

M/s KRC Infrastructure & Projects Private Limited has submitted a Petition on 06.02.2018, under Section 16 & 181 of the Electricity Act, 2003 for taking on record deemed Distribution Licensee status of, M/s. KRC Infrastructure and Projects Pvt. Ltd., for the IT & ITeS SEZ at Survey No. 65 (p), Kharadi, Tal Haveli, Dist Pune, and for issuing the Specific Conditions of Distribution Licence applicable to the Petitioner.

The main prayers of the Petitioner are as under-

i) *take on record the deemed Distribution Licensee status of the Petitioner, M/s KRC Infrastructure and Projects Private Limited, under Section 14 of the Electricity Act, 2003 in terms of notification dated March 3, 2010, issued by the Ministry of Commerce & Industry (Department of Commerce), Government of India.*

ii) *issue Specific Conditions of Distribution Licence applicable to M/s KRC Infrastructure and Projects Private Limited.*

iii) *Condone any inadvertent omissions/errors/shortcomings and permit M/s KRC Infrastructure and Projects Private Limited to add/change/modify/alter this filing and make further submissions as may be required at a future date.*

iv) *Pass such Orders as the Hon'ble Commission may deem fit in the facts of the present case.*

**The petitioner has filed the Addendum Petition on 30.05.2018 with additional submissions.**

Prayers in the Addendum Petition:

i). *take on record the deemed Distribution Licensee status of the Petitioner, M/s KRC Infrastructure and Projects Private Limited, under Section 14 of the Electricity Act, 2003 in terms of notification dated March 3, 2010, issued by the Ministry of Commerce & Industry (Department of Commerce), Government of India.*

ii). *specify the notified SEZ area of 4.95 Hectares in case of M/s KRC Infrastructure and Projects Private Limited as 'area of supply', in the Specific Conditions of Distribution Licence applicable to M/s KRC Infrastructure and Projects Private Limited.*

iii). *to allow the Petitioner, in the interim, to charge consumers in its licence area, the tariff that is applicable for the respective category of consumers in the MSEDCL area of supply, as modified from time to time, as the 'ceiling tariff' in its area of supply and approve the appropriate tariff schedule.*

iv). *allow the Petitioner to charge consumers in its licence area the same Schedule of Charges that is applicable in the MSEDCL area of supply, as modified from time to time.*

- v). *Condone any inadvertent omissions/errors/shortcomings and permit M/s KRC Infrastructure and Projects Private Limited to add/change/modify/alter this filing and make further submissions as may be required at a future date.*
- vi). *Pass such Orders as the Hon'ble Commission may deem fit in the facts of the present case.*

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
