

NOTICE

Subject: Petition of Jawaharlal Nehru Port Trust (JNPT) for taking on record the deemed Distribution Licensee status.

- **Case No. 47 of 2018**

Jawaharlal Nehru Port Trust (JNPT) has submitted a Petition on 12.01.2018, under Section 14,16,181 of EA 2003 and Regulation 8.16.2 of the MERC (General Conditions of Distribution Licence) Regulations, 2006 for taking on record the deemed Distribution Licensee status of the Petitioner, JNPT for the Multiproduct Sector Specific SEZ for services sector being developed at Village sheva, Navi Mumbai and for issuing the Specific Conditions of Distribution Licence, as may be made applicable to the Petitioner.

The main prayers of the Petitioner are as under-

- i). *To take on record the Deemed Distribution Licensee status of the Petitioner, M/s. Jawaharlal Nehru Port Trust, under Section 14 of the Electricity Act, 2003 and Section 49 of SEZ Act, 2005.*
- ii). *To Issue Specific Conditions of Distribution License applicable to the Petitioner, M/s. Jawaharlal Nehru Port Trust.*
- iii). *To approve the provisional tariff equivalent to MSEDCL tariff for its area of supply.*
- iv). *To initiate the proceedings at the earliest to allow Petitioner to commence business operation from December 2018 onwards.*
- v). *Condone any inadvertent omissions/errors/shortcomings and permit the Petitioner to add/change/modify/alter this filing and make further submissions as may be required at a future date.*
- vi). *Pass such orders as the Hon'ble Commission may deem fit as per the facts of the present case.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Sunday, 10 June, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the authorised consumer representatives before the scheduled date of hearing.
4. The CR's may submit the say on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner before hearing.
5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
