Subject: Petition of Mahindra CIE Automotive Limited seeking action against Maharashtra State Electricity Distribution Company Limited for non-compliance of the Distribution Open Access Regulations, 2016 and Order dated 11 August, 2017 in Case No. 139 of 2016, adoption of incorrect monthly billing methodology and to direction to revise incorrect monthly billing methodology.

Mahindra CIE Automotive Limited has submitted a Petition on 30.01.2018 under Section 142, 146 and 149 of EA 2003 seeking action against Maharashtra State Electricity Distribution Company Limited for non-compliance of the Distribution Open Access Regulations, 2016 and Order dated 11 August, 2017 in Case No. 139 of 2016, adoption of incorrect monthly billing methodology and to direction to revise incorrect monthly billing methodology.

The main prayers of the Petitioner are as under-

- a) Direct the Respondent to forthwith correct the bills raised upon the Petitioner from May 2016, due to incorrect adjustment of power and no later than seven (7) days from date of Order;
- b) Direct MSEDCL to credit the amount of Rs.2,02,29,726/- (Rupees Two Crores Two Lacs Twenty None Thousand Seven Hundred and Twenty-Six Only) towards Foundry Division Urse and Rs. 1,48,76,179 (Rupees One Crore Forty-Eight Lacs Seventy-Six Thousand Seven Hundred Twenty-Six Only) for Forging Division Chakan in respect of loss incurred by the Petitioner on account of alleged over-injected units which occurred due to incorrect billing method by MSEDCL in the ensuing billing cycle;
- c) Direct the Respondent to adopt correct practice of set-off open access power i.e. first conventional OA power and then RE power in accordance with DOAR, 2016;
- d) Award costs of these proceedings against the Respondent and pay to the Petitioner; and
- e) Pass such further order(s) as the Hon'ble Commission may deem just in the facts of the present case.
