

**NOTICE**

Subject: Petition of Ghatge Patil Industries Limited under Section 42 of the Electricity Act, 2003 pertaining to denial of short term open access by MSEDCL.

- **Case No. 83 of 2018**

Ghatge Patil Industries Limited has submitted a Petition on 14.02.2018, pertaining to denial of Short Term Open Access under Section 42 of the Electricity Act, 2003.

The Petitioner is submitting that there is an urgent prayer for passing an *interim order* directing Respondent No.1 to grant Open Access permission to the Petitioner and prays to:

Subsequently, The Petitioner filed an Interim Application before the Commission on 28.03.2018.

- a) *Pass an ad-interim ex-parte order of directing Respondent No.1 to issue Open Access permissions in accordance with present regulatory regime w.e.f. February1, 2018 as per applications of the Petitioner;*
- b) *Pass an ad-interim ex-parte order directing Respondent No.1 to pay all outstanding amounts due to the Petitioner till the date of termination of WEPAs,*
- c) *Confirm the ex-parte orders after notice to the Respondents; and*
- d) *Pass such other order(s) as the Hon'ble Commission may deem just in the facts of the present case.*

**MAIN PRAYER**

- a) *Direct the Respondent No.1 to grant STOA permission to the Petitioner for self-use from the wind turbines for the period commencing from February1, 2018 onwards;*
- b) *Direct the Respondent No.1 to adjust the units supplied to Respondent No.1 against the Petitioners power bills until the disposal of the present Petition;*
- c) *Award costs of these proceedings against the Respondent No.1 and in favour of the Petitioner; and*
- d) *Pass such other order(s) as the Hon'ble Commission may deem just in the facts of the present case.*

The Interim Prayers of Interim Application dated 28.03.2018 are as under -

a) *“Direct Respondent No. 1 to issue Open Access permission in accordance with present regulatory regime w.e.f. February 1, 2018;*

b) *Pass such further orders as this Hon'ble Commission deems fit and appropriate under the circumstances of the case and in the interest of justice”.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Saturday, 16 June, 2018 at 10.00 hrs** in the office of the Commission at 13<sup>th</sup> floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondents and the authorised consumer representatives before the scheduled date of hearing.

4. The Respondents are directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and authorized Consumer Representatives, the CRs may submit there say before hearing.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
