

NOTICE

Subject: Petition of Roha Dychem Private Limited against Maharashtra State Electricity Distribution Company Limited for directions to the Respondent in regard to the terms of Open Access granted and to be granted by the Respondent for the period.

- **Case No. 119 of 2018**

Roha Dychem Private Limited has submitted a Petition on 09.04.2018 under Section 42 of the Electricity Act, 2003 against Maharashtra State Electricity Distribution Company Limited for directions to the Respondent in regard to the terms of Open Access granted and to be granted by the Respondent for the period.

The main prayers of the Petitioner are as under-

- a. *Direct Respondent No.1 to grant OA to the Petitioner to the extent of 10 MW from March, 2018 onwards;*
- b. *Direct Respondent No.1 to compensate the Petitioner for the power injected in the grid which is unadjusted in OA from March 2018 at preferential tariff;*
- c. *Direct Respondent No.1 to adhere to DOA Regulations and Practice Directions whilst processing OA permissions in letter and spirit;*
- d. *Award costs of this proceeding against the Respondents and in favour of the Petitioner and;*
- e. *Pass such other order(s) as the Hon'ble Commission may deem just in the facts of the present case.*

Interim Relief -

- a) *Pass an ad-interim order directing Respondent No. 1 to immediately grant OA to the extent applied for by the Petitioner from March 2018 onwards; and*
- b) *Pass such other order(s) as this Hon'ble Commission may deem just in the facts of the present case.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Saturday, 16 June, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

3. The Petitioner is directed to immediately serve a copy of its above mentioned Petition (both in soft and hard Copy) to the Respondents and the authorised consumer representatives before the scheduled date of hearing.

4. The Respondents are directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and authorized Consumer Representatives, the CRs may submit there say before hearing.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
