Subject: Petition of Amravati Power Transmission Company Limited (APTCL) for replacing the encumbrance created on the assets of APTCL in favour of PFC and REC with L&T Infrastructure Finance Co. Ltd, for the purpose of the licensed business under the provisions of Section 15.3 of MERC (Transmission Licence Conditions) Regulations, 2004 as amended in 2006 and 2017.

- **Case No. 86 of 2018**

Amravati Power Transmission Company Limited (APTCL) has submitted a Petition on 22.02.2018, for replacing the encumbrance created on the assets of APTCL in favour of PFC and REC with L&T Infrastructure Finance Co. Ltd, for the purpose of the licensed business under the provisions of Section 15.3 of MERC (Transmission Licence Conditions) Regulations, 2004 as amended in 2006 and 2017.

The main prayers of the Petitioner are as under-

- (a) *Provide approval for replacing the encumbrance created on the moveable and immoveable assets of the Borrower way of hypothecation/assignment/mortgage/pledge of the immovable/moveable assets of APTCL in favour of PFC and REC with L&T Infrastructure Finance Company Limited ("L&T");*
- (b) *Condone the delay/any inadvertent omissions/errors/short comings and permit APTCL to add/change/modify/alter this filling and make further submissions as may be required at a future date; and*
- (c) *Pass such other and further orders as are deemed fit and proper in the facts and circumstances of the case.*

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
