Subject: Petition of Shri Shivaji Kondiba Hatkar against MSEDCL under Section 142 & 149 of the Electricity Act, 2003 for non-compliance of the CGRF, Kolhapur Case No.38 of 2017-18 Order dated 22.11.2017.

- **Case No. 51 of 2018**

Shri Shivaji Kondiba Hatkar has submitted a Petition on 17.01.2018, against MSEDCL under Section 142 & 149 of the Electricity Act, 2003 for non-compliance of the CGRF, Kolhapur Case No.38 of 2017-18 Order dated 22.11.2017.

The main prayers of the Petitioner are as under-

- 3) कृती मानका नूसार विलंबाची भरपाई प्रतिवादी यानी स्वताहोउन देणेची आहे, याची जाणीव प्रतिवादी याना देणेत यावी व वादी याना त्यांच्या अर्जानुसार विलंबाची भरपाई न दिल्यास या बाबत वादी हे संबंधीत मंच यांच्या कडे दाद मागू शकतात हे निश्चित व्हावे ही विनंती. या बाबत मा. आयोग यानी केस क्र.४२/२०१६ आदेश दि. १४-डिसेंबर-२०१६ चे पालनही प्रतिवादी यानी आजतागायत केलेले नाही. ही बाबही गंभीर आहे.

- 5) जरूर भासल्यास याचिकेत योग्य ती दुरुस्तीस परवानगी असावी ही विनंती.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
