- **Case No. 50 of 2018**

Shri Hussian Aappso Mulla has submitted a Petition on 17.01.2018, against MSEDCL under Section 142 & 149 of EA 2003 for non-compliance of the Electricity Ombudsman Order No.90 of 2017 dated 06.10.2017 and Commission's Order in Case No. 43 of 2005 dated 01.06.2006.

The main prayers of the Petitioner are as under-

- 4) कृती मानका नुसार विलंबाची भरपाई प्रतिवादी यानी स्वताहोउन देणेची आहे, याची जाणीव प्रतिवादी याना देणेत यावी ही विनंती.
- 5) इतर न्यायाचे आदेश वादी याचे वतीने व्हावेत ही विनंती.
- 6) जरूर भासल्यास याचिकेत योग्य ती दुरुस्तीस परवानगी असावी ही विनंती.
