d) Direct MSEDCL to pay carrying cost at the rate of 15% per annum of the delay in payment of the Late/Delayed Payment Surcharge by MSEDCL;

e) Award cost of the petition in favour of the petitioner;

f) Direct MSEDCL to comply with the terms of WEPAs by honoring its commitments under WEPAs;

g) Call for the entire record relating to the case of Petitioner and after perusing the same, pass such appropriate order or direction;

h) Pass, any other appropriate relief, order or direction, which this Hon'ble Commission deems just and proper in the facts and circumstances of the present case, in favour of Petitioner.
