Ultra mega Power Private Limited (formerly known as R.S. - (b) Pending the final outcome in the present Petition, the Respondent No.1 may kindly be directed to off-take the power generated and injected into the grid at the tariff of Rs. 5.70 kWh (i.e. tariff prevailing on the date of commissioning of the 2 wind power projects of the Petitioner);
- (c) Pass any other order or further orders or directions that this Hon'ble Commission may deem necessary in the facts and circumstances of the case.
