Subject: Petition of Grafica Flextronica against MSEDCL under Section 142 and 146 of the Electricity Act, 2003 for non compliance of the Appellate Authority Order dated 28.06.2017 passed in Appeal No 223 of 2014 under Section 127 of EA 2003.

- **Case No. 64 of 2018**

Grafica Flextronica has submitted a Petition on 25.01.2018, against MSEDCL under Section 142 and 146 of the Electricity Act, 2003 for non compliance of the Appellate Authority Order dated 28.06.2017 passed in Appeal No 223 of 2014 under Section 127 of EA 2003.

The main prayers of the Petitioner are as under-

a) *Invocation of section 142 & 146 of Electricity Act 2003 for non compliance of Appellate Order no – 223 / 2014 & non implementation of ACT, Rules & Regulations.*

b) *Refund the amount of Rs. 4,71,440 as directed by order along with interest vide E A 2003 sec 127 (6) @ 16 % from date of deposit to date of order 28 June 2017.*

c) *Order was to be complied within 30 days from date of order 28 June 2017. So interest @ 9 % may be given from 28 July 2017 till date of credit to our H T consumer account No. 001849 016 217 as per sec 62 (6) of E A 2003.*

d) *As per conclusion of the order, disciplinary action to be taken on the concerned officer for monetary loss incurred by MSEDCL.*

e) *Cost of petition to the Petitioner*

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
