Subject: Petition of M/s Shraddha Agro Foods against MSEDCL under Section 142 and 146 of the Electricity Act, 2003 for non-compliance Compliance of CGRF Kalyan Order No.1063/2015-16 dt. 14.12.2017.

- **Case No. 85 of 2018**

M/s Shraddha Agro Foods has submitted a Petition on 21.02.2018, against MSEDCL under Section 142 and 146 of the Electricity Act, 2003 for non-compliance Compliance of CGRF Kalyan Order No.1063/2015-16 dt. 14.12.2017.

The main prayers of the Petitioner are as under-

- a) *Invocation of section 142 & 146 of Electricity Act 2003 for non compliance of CGRF order no 1063, & non implementation of ACT, Rules & Regulations.*
- b) *Refund **Rs. 5,07,223 + DPC & interest recovered along with interest on refund amount at RBI rate from date of deposit to date of credit. Amount to be credited in consumer no. 010790 001 538 M/s. Shraddha Agro products as per Order of CGRF.***
- c) *Interest on entire refund amount from **45 days of CGRF order dt 14 Dec' 2017 for non compliance till the date of credit of amount in consumer's account as per Sec 62 (6) of E A 2003.***
- d) *The cost of the petition to the petitioner.*

2. I am directed to communicate that the hearing in the above matter will be held in the presence of the authorized consumer representatives on **Tuesday, 19 June, 2018 at 10.00 hrs** in the office of the Commission at 13th floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai - 400 005.

4. The Respondents are directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and authorized Consumer Representatives, the CRs may submit there say before hearing.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
