Subject: Petition of Mahindra Lifespace Developers Ltd., seeking compliance o the Order dated 31.01.2018 passed by the Appellate Authority under Section 127 of the EA, 2003 in Appeal No 183 of 2010.

- **Case No. 106 of 2018**

Mahindra Lifespace Developers Ltd., has submitted a Petition on 27.03.2018, Under Section 142 & 146 of the Electricity Act, 2003 seeking compliance o the Order dated 31.01.2018 passed by the Appellate Authority under Section 127 of the EA, 2003 in Appeal No 183 of 2010.

The main prayers of the Petitioner are as under-

- (a) direct and order the Respondent Nos. 1 and 2 to forthwith refund to the Petitioner the amount of Rs.10,82,02,200/- along with interest thereon @ 16% p.a. compounded every six months from the date of the order till payment or realization;*
- (b) to take appropriate action against the Respondent Nos. 1 and 2 as provided under Section 142 and 146 of the Act for non-compliance of the order dated 31st January 2018 passed by the Appellate Authority in Appeal No.183 of 2010;*
- (c) pass such other and further relief as this Hon'ble Commission may deem fit and proper in the facts and circumstances of the present case.*

4. The Respondents are directed to submit the say immediately on affidavit in 1+6 copies to the Commission with documents, if any, on the above mentioned Petition, with a copy to the Petitioner and authorized Consumer Representatives, the CRs may submit there say before hearing.

5. The Parties are directed to file their Petition and submissions in MS -Word file and PDF version as far as possible and to file 1+6 copies of all relevant documents/citations produced during the proceedings.
